FRESH WIND VISION TEAM GENERAL REQUIREMENTS:

To participate in any of the Vision Team Ministries at Fresh Wind, the following requirements MUST be met: Complete six-week Vision Team Class

- 1. Be a born-again Christian, having become baptized in water in good standing for at least six weeks.
- 2. Pastor has in the past and may approve on an individual basis, those who have Bible School Training and/or have been recruited by the Ministry for involvement. Pastor Phil may also approve a person joining Fresh Wind in a watch care status for ministry involvement from another Bible-believing Church.
- 3. Living a lifestyle consistent with Christian principles, the Pastor's vision, and the rules and regulations governing the Vision Team Ministries.
- 4. Have the temperament and capability to perform the duties established for the Vision Team Ministry to which application is made.
- 5. Consistently attend at least one bible study and/or one of the Sunday worship services, even though one may be required to work another. Persons working nights must inform and receive approval from the ministry operations manager to be excused from Bible Study.
- 6. Attend the monthly scheduled in-person and/or Zoom meetings established for the Vision Team Ministry to which the application is made.
- 7. Be willing to consistently support the Ministry, praying and financially, and MUST be a consistent giver in both Tithes and Offerings. (Malachi 3:8)
- 8. No Ministry of Vision Team Worker will be allowed to work in more than three (3) functioning areas of the Ministry of Helps and only one position during worship.
- 9. If a Ministry of Helps Worker has been inactive for 30 days in an area of the Ministry of Helps, the Worker must re-apply for the Vision Team Ministry.

FRESH WIND VISION TEAM SPECIAL REQUIREMENTS:

- All Vision Team Ministry workers are to report to their respective stations at least 30 minutes before the service they will work unless otherwise specified. Either the Department/auxiliary Head or assistant must be in service at all times to cover their area.
- No individual can print or reproduce any material bearing the name of Fresh Wind Christian Center for ministry use or personal use without notifying the Pastor or Staff.
- No individual or Department/Auxiliary head is to plan a program and/or invite a speaker without the approval of the Pastor.
- No Vision Team Ministry Worker is to engage in any private counseling of visitors or other members on the premises of Fresh Wind Christian Center. All counseling needs are to be referred to the Ministerial Staff.
- All Vision Team Ministry Workers are to adhere to the established rules and regulations as set by Church Administration, governing leaves of absence, disciplinary actions, and church membership.
- If a Vision Team Ministry Worker's conduct is unbecoming or contrary to a Christian lifestyle, that worker will be relieved of his/her position for three months. After that time, he/she may be considered for reinstatement.
- When a Vision Team Ministry Worker is relieved of his/her position, he/she must continue attending worship service, bible study, and other normal church functions.
- All male Vision Team Ministry worker's earrings must be removed while working in the sanctuary or in the presence of members and visitors.
- Piercings other than earlobes will not be allowed. No Vision Team Ministry worker can wear piercings while working in the sanctuary or on live stream, Nursery or in the presence of members and visitors.
